In Person No Excuse (Early) Voting starts Thursday, October 31

LOUISVILLE, Ky. (10/30/2024): October 31 marks the beginning of In-Person No Excuse (Early) Voting. Jefferson County voters wishing to cast their ballots before November 5 will have a three-day window to do so.

Jefferson County Clerk Bobbie Holsclaw emphasized that enhancing access to voting will lead to higher turnout at the polls.

"Our goal is to increase voter participation by improving access to the ballot box, while ensuring the integrity and security of the electoral process," stated Bobbie Holsclaw, Jefferson County Clerk. "We are thrilled to provide these conveniences for the General Election, empowering every eligible voter in Jefferson County to play an essential role in shaping the future of their communities."

Any registered voter is eligible to vote early before November 5. In-Person No Excuse (Early) Voting will occur on October 31, November 1, and November 2, from 8:00 a.m. to 6:00 p.m. The following locations will be available:
