WHO: The Jefferson County Clerk's Office and candidates seeking election to the Jefferson County Public Schools Board of Education.

WHAT: The filing deadline for candidates wishing to appear on the ballot for the Jefferson County Public Schools Board of Education has passed. WHY: Kentucky law requires candidates for the Jefferson County Public Schools Board of Education to file the appropriate paperwork by the established deadline in order to qualify for placement on the ballot in the General Election.
